Definition.

"Ads Launch Assistant" – means the Semrush service designed to assist Users to create, manage and get statistics on User's advertisement campaign in Meta and Google Ads services as described more fully at <https://www.semrush.com/apps/ads-launch-assistant/> or another URL we designate.

"Google Ads Services" - means services for placing and distributing your advertisement campaigns on Google platform.

"Meta Ads Services" - means services for placing and distributing your advertisement campaigns on Meta platforms, including but not limited to, Instagram and Facebook.

Right To Ads Launch Assistant. Semrush hereby grants you permission to access and use Ads Launch Assistant in accordance with these Ads Launch Assistant Terms.

Privacy. Google may request authorization documents to verify your Google Ads Services account, which we will transfer to Google on your behalf. By accessing or using Ads Launch Assistant, you authorize us to obtain, process, store, use and

transmit your personal data in accordance with our Privacy Policy available at <https://www.semrush.com/company/legal/privacy-policy/>, which forms an integral part of these Ads Launch Assistant Terms.

2. ADS LAUNCH ASSISTANT SPECIFICS

Ads Launch Assistant. Ads Launch Assistant helps you to create, manage and get statistics for your advertising campaigns in Meta Ads Services and Google Ads Services. You agree to give us the access necessary for provision of Ads Launch Assistant services to you and the right to parse your website for analyzing, including but not limited, the language, tone of voice, semantic of content. You agree that you are solely responsible for your advertising campaign content, settings and campaign results, and you shall fully comply with Meta and Google terms and conditions and applicable laws in relation to your advertisement content. Ads Launch Assistant uses the data received from Google APIs and will adhere to [Google API Services User Data Policy](#), including the Limited Use requirements.

Google Promotional Credits. Google may provide you with promotional credits based on certain conditions set forth in Google's special terms and conditions located at <https://support.google.com/adspolicy/answer/1396257?hl=en>.

3. SUBSCRIPTION PLAN. WALLET AND SEMRUSH FEES

Subscription plan. If you are willing to connect your existing Meta Ads Services account and/or you have a Google Ads Services account which you would like to connect or create the new one, you shall choose the Subscription Plan that suits your goals in creating the advertising campaigns. All the Google Spendings or Meta Spendings will be paid directly to Meta or Google. If in certain months you exceed the limits set forth in chosen Subscription Plan you will be automatically upgraded to higher Subscription Plan with the respective increase of the Fees.

Wallet. If you do not have Google Ads Services account and you are willing to create it through Services and/or connect Meta Ads Services account and use Ads Launch Assistant as Paid Services, you shall be responsible for replenishing your account ("Wallet") with the amount of money you are going to spend on your Google advertising campaigns and Semrush Fees. Your Wallet balance will be updated daily, showing your spendings in Google ads services

("Google Spending") and Semrush Fees for Ads Launch Assistant Services. Other spendings in Meta Ads Services ("Meta Spendings") will be paid directly by you to Meta. Upon your request we will provide you with a monthly report showing monthly Google Spending, Meta Spending and Semrush Fees. If there is no money in your Wallet, you will not be able to use Paid Services. Google Payments may be adjusted depending on Google policies. You are not entitled to any credit interest for the amount in your Wallet account.

Semrush Fees. A Semrush Fee of 10% is applied to every Google Spending and/or Meta Spending you make. Semrush Fees will be deducted from your Wallet account on the day when a Google Spending and/or Meta Spending is made.
