SEMRUSH "MOM & POP CHALLENGE" PROMOTION OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.

By submitting an entry in the Semrush "Mom & Pop Challenge" Promotion (the "<u>Promotion</u>"), you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

1. OVERVIEW: The Promotion consists of a qualifier sweepstakes (the "<u>Sweepstakes</u>") and the Mom & Pop Shop Challenge (the "<u>Contest</u>"), the details of which are set forth below. In summary, the Sweepstakes consists of a random draw to award one entrant (the "<u>Sweepstakes Prize Winner</u>") a prize consisting of a \$100 gift card and entry to the Contest (the "<u>Sweepstakes Prize</u>") and grant 499 additional entrants (the "<u>Event Contestants</u>") the opportunity to participate in the Contest, the prizes for which include a \$25,000.00 First Place Contest Prize, a \$10,000.00 Second Place Contest Prize, and a \$5,000.00 Third Place Contest Prize (collectively, the "<u>Contest Prizes</u>"). The Sweepstakes and Contest may be referred to collectively herein as the Promotion.

2. ELIGIBILITY: This Promotion is open only to entrants who are legal residents of one of the fifty United States or District of Columbia and at least 18 years of age (or at least 19 years of age if entrant is a resident of Alabama or Nebraska). Employees of Semrush Inc. ("<u>Sponsor</u>"), its advertising, promotional and PR agencies ("<u>Agencies</u>"), and any other entities or individuals involved in the Promotion or the Event (as defined in Rule 4, below), along with any of their immediate family members (defined as parents, spouses, siblings or children; whether biological, adopted, step or in-law) and their household members (whether related or not) are not eligible to participate in the Promotion.

3. Sweepstakes entries will be accepted starting on March 13 at 9:00 a.m. ET (the "Start Date") and must be received by 11:59 p.m. ET on March 21, 2024 (the "End Date") in order to be eligible for the Sweepstakes Drawing. The period from the Start Date through the End Date shall be referred to herein as the "Sweepstakes Entry Period." Limit one entry per person throughout the entire Sweepstakes Entry Period. Sponsor is not responsible for late, lost, illegible, incomplete or misdirected entries. Entries become the property of Sponsor and may not be acknowledged or returned. 4. VOID WHERE PROHIBITED BY LAW.

5. SWEEPSTAKES WINNER SELECTION AND PRIZE: One (1) eligible entrant will be randomly selected as the potential prize winner in the Sweepstakes from among all eligible entries received during the Sweepstakes Entry Period in a drawing to be held on or about March 22, 2024 (the "<u>Drawing</u>"). Subject to passing the verification process detailed in Rule 6, below), such potential prize winner will be declared the "<u>Sweepstakes Prize Winner</u>," and such Prize Winner will be awarded a prize consisting of a \$100 Visa® gift card (the "<u>Sweepstakes Prize</u>"). Total approximate retail value of all prizes to be awarded in the Sweepstakes is \$100. Sponsor reserves the right to award an alternative brand of gift card in its sole discretion, and such Sweepstakes Prize may be awarded in physical or digital format, at Sponsor's sole discretion. Sweepstakes Prize is subject to terms and conditions imposed by card issuer. All taxes on the Sweepstakes Prize are the sole responsibility of the Sweepstakes Prize Winner. 6. EVENT CONTESTANT SELECTION AND DETAILS: After the potential Sweepstakes Prize Winner is randomly selected, 499 other eligible entrants will be randomly selected from the remaining eligible entries in the Drawing (the potential Sweepstakes Prize Winner and 499 other selected entrants to be referred to herein as the "Potential Contestants"). The Potential Contestants will qualify to participate in the Event and compete for the Contest prizes, subject to Sponsor's verification of the Potential Contestant's eligibility, compliance with these Official Rules, and acceptance of the required Registration/Release Form, as detailed in Rule 7, below. Once Sponsor has verified a Potential Contestant is eligible to compete in the Event, such Potential Contestant will thereafter be referred to as an "Event Contestant" and collectively as the "Event Contestants"). 7. SWEEPSTAKES DRAWING DETAILS, SWEEPSTAKES PRIZE WINNER/EVENT CONTESTANT VERIFICATION: The potential Sweepstakes Prize Winner and Potential Contestants will each be notified via email at the email addresses provided in their entry forms following the Drawing, on or around March 22, 2024 ("Notification"). The Potential Contestants must have agreed to the Confirmation of Eligibility and Liability/Publicity Release (where legal) (the "Registration/Release Form") or a potential Sweepstakes Prize Winner or Event Contestant (as the case may be) may be disqualified and lose any claim to their Sweepstakes Prize (if the potential Sweepstakes Prize Winner) or opportunity to participate in the Event (if a potential Event Contestant). Terms and Conditions, instructions and protocols as communicated by Sponsor, the Sweepstakes Prize (in the case of Sweepstakes Prize Winner) or participation in the Event and opportunity to win a prize in the Contest (in the case of Event Contestants) may be forfeited and the Potential Contestant disqualified. A maximum of one Sweepstakes Prize and 500 Event Contestant spots are available.

8. CONTEST PARTICIPATION, CONTEST WINNER DETERMINATION, AND CONTEST PRIZE: Up to five hundred (500) Event Contestants will follow a map of the Event course (the "Course"), in accordance and compliance with all Event Terms and Conditions as set forth in the Registration/Release Form and as otherwise communicated by Sponsor on the day of the Event (collectively, the "Event <u>Rules</u>"), to visit eight (8) "mom and pop shops" in New York City (the "<u>Shops</u>") in the order they choose. As the Event Contestants visit each Shop, they will answer one multiple choice question and select a corresponding sticker to place on their map, and upon completing the Course requirements at each Shop designated on the map, will return to the Event finish area. This is a timed Event, and Event Contestants will win based on their time to complete the Course in combination with all correct answers they give at each Shop. The top three (3) finishers will be awarded a cash prize (each a "Contest Prize") as follows: the Contest Prize for first place is \$25,000.00; the Contest Prize for second place is \$10,000.00; and the Contest Prize for third place is \$5,000.00 (collectively the "Contest Prizes"). In the event of a tie between Event Contestants in the course completion time and scoring for correct answers, to determine a winning position, the tie will be broken based on a series of trivia questions asked of the tied contestants until one Event Contestant answers incorrectly, and the Event Contestant that answers correctly will be declared the appropriate Contest Prize winner.

The Contest Prizes may be awarded in cash, check, or wire format, at Sponsor's sole discretion. Contest Prize winners must sign an affidavit of eligibility on location at the time of announcement of the Contest Prizes or may be disqualified or deemed ineligible for a Contest Prize at the sole discretion of Semrush. All taxes on the Contest Prizes are the sole responsibility of the individual Contest Prize Winner.
